## Accessing My Health Declarations

When you are ready to begin click on the Start My Health Declarations link

A window will open with the ImmiAccount home page. From this window you can:

- Login to ImmiAccount if you already have an account set up for yourself, or
- Create a new ImmiAccount to access the department's online services, including My Health Declarations, by clicking on the **Create ImmiAccount** button.

**Note:** You need to complete your health declaration questions 'upfront' (that is, prior to lodging your visa application) in order for us to determine which health examinations (if any) you are required to complete.
